1. Check for the Building Permit Fee, Erosion Control Fee, Plans Review (1/2 of building permit), Impact Fee Adm (Impact Fee x 2%)
2. Check for 75% of Impact Fee
3. Check for 25% of Impact Fee
4. Check for the Nolensville Facilities Tax (\$2 per sq. ft. of floor area)
