Defensive Driving – 4 hour Class

You are receiving this because you have been found guilty of the charge(s) against you. The Court will dismiss these charge(s) if the all of the following conditions are met:

- 1) You must attend a 4-hour Defensive Driving Class and **YOU must submit the Certificate of Completion to the Court** within **60 days** of your court appearance, unless other time arrangements have been made.
- 2) All fines and/or costs must be paid within **2 weeks** of your court appearance.

You may attend a 4-hour Defensive Driving class at any location that has been certified by the State of Tennessee (**except online classes**). Following is a partial list of available schools. You can fax it to (615) 776-3631, email it to court@nolensvilletn.gov, mail it to P.O. Box 547, Nolensville, TN 37135, or bring it by our office at 7218 Nolensville Road, Monday thru Friday from 8am to 4pm.

If your Certificate has not been received or if the payment of fines and/or costs has not been made within the prescribed time, the Court may charge you with Contempt of Court, assess an additional \$50 fine, and notify the Tennessee Department of Safety to proceed with the suspension of your Driver's License.

Remember, it is **YOUR RESPONSIBILITY** to return the CERTIFICATE OF COMPLETION to the Court on time. If you have any questions or require a time extension, please call the Court Clerk at (615) 776-6684.
